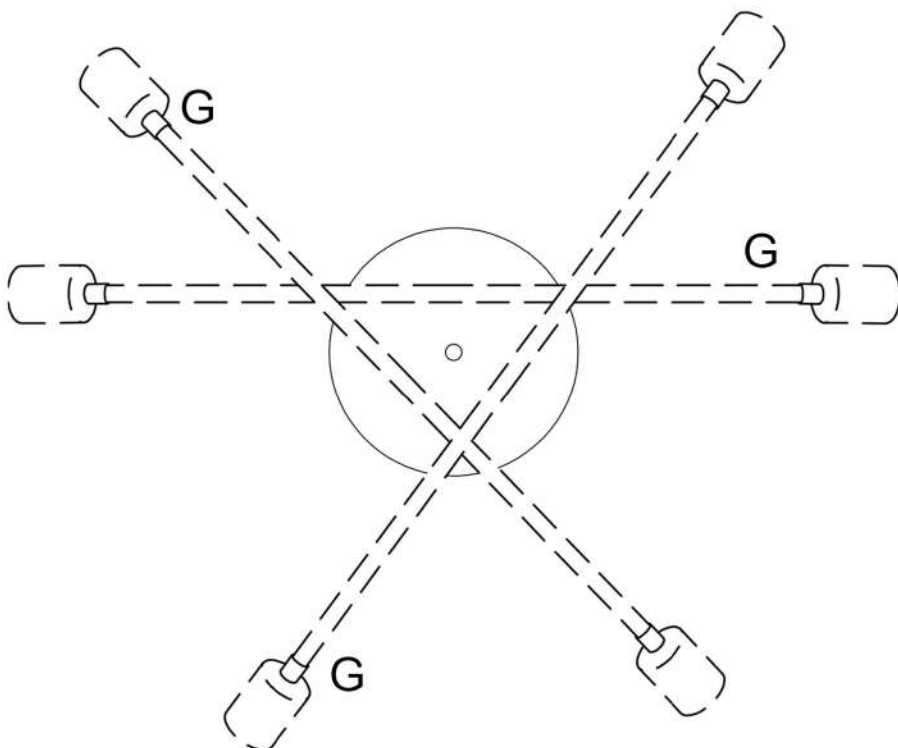
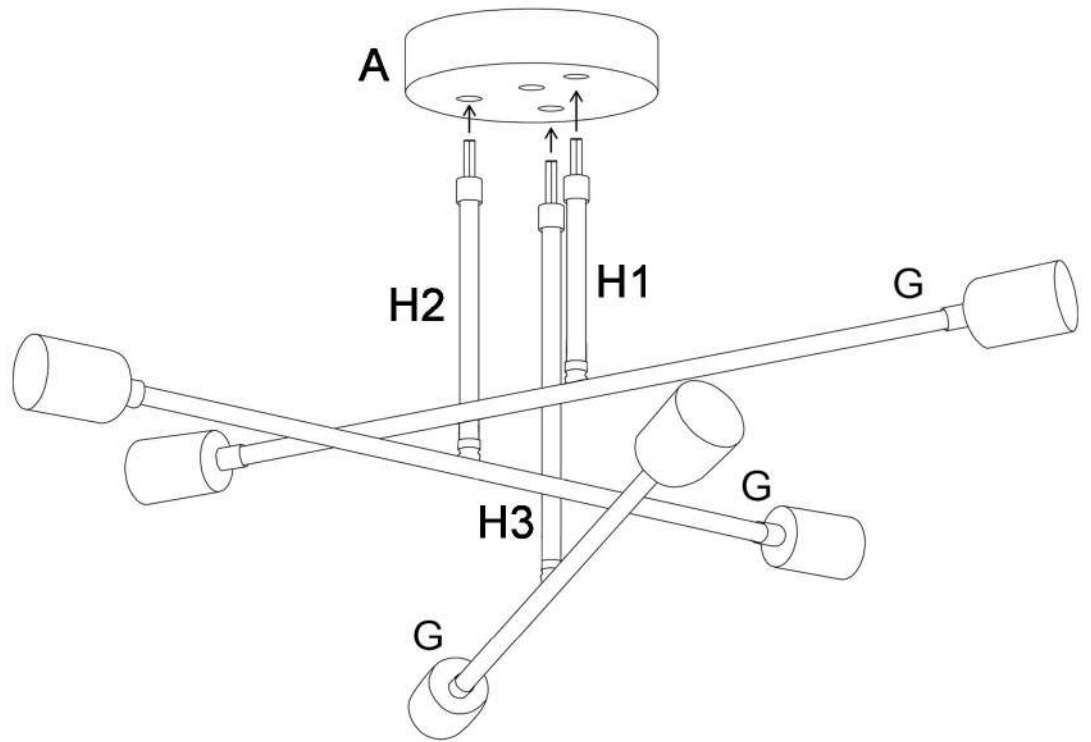
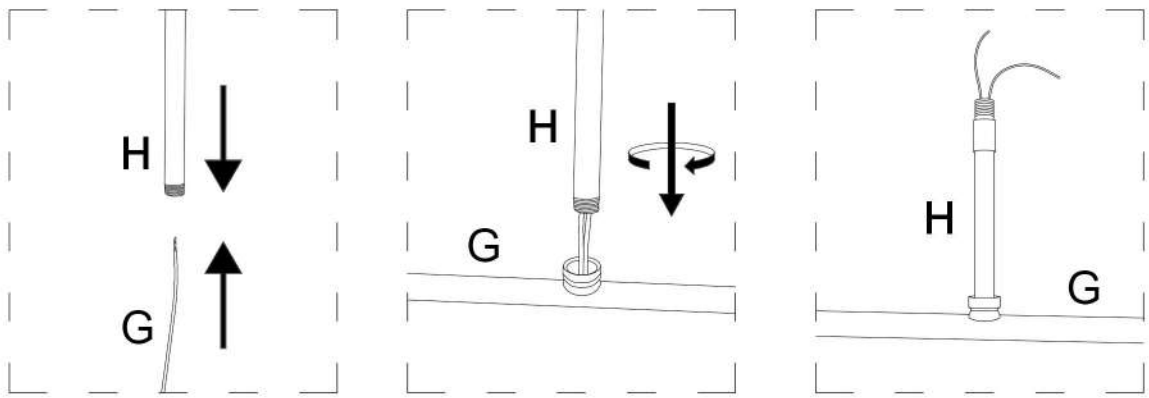


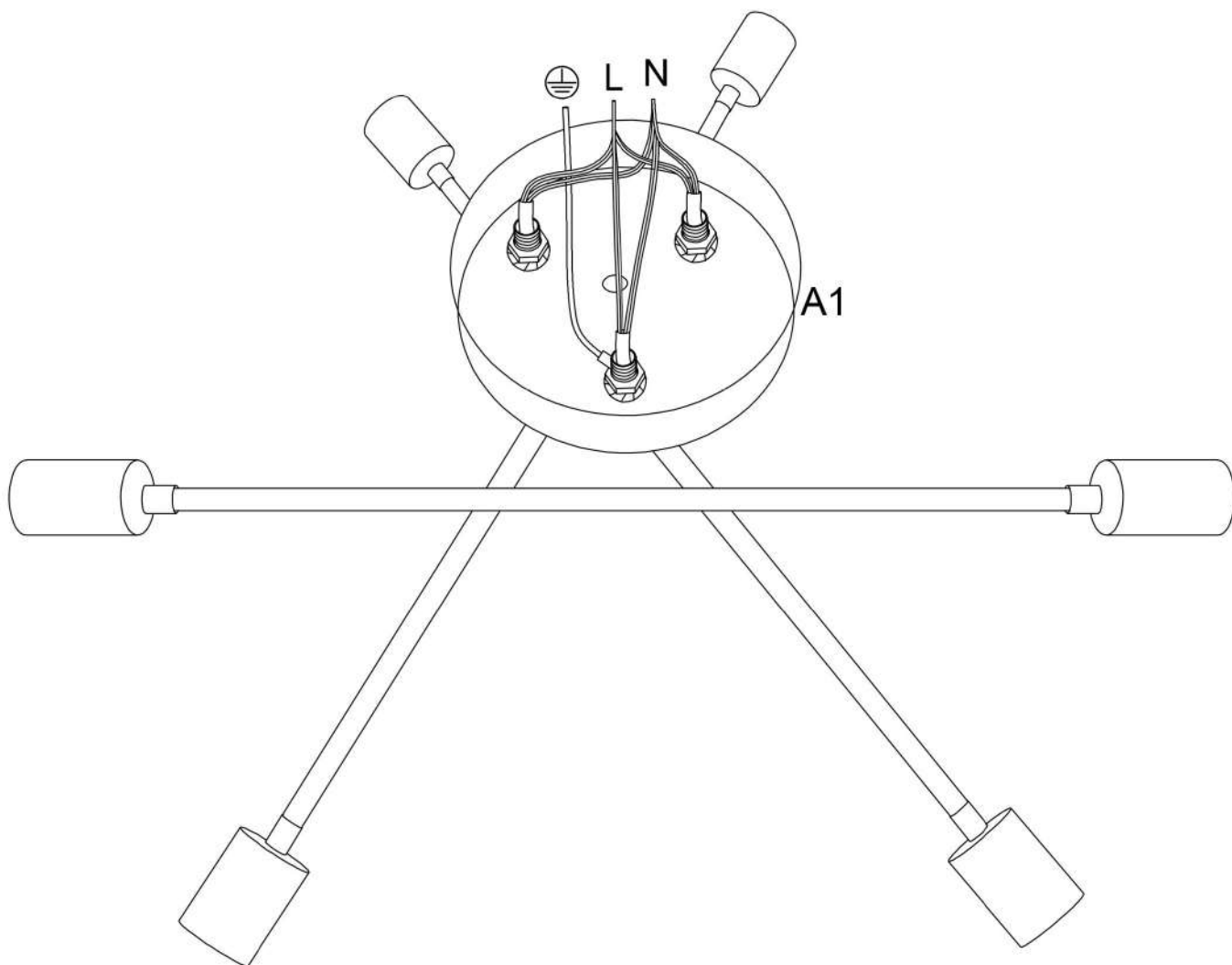
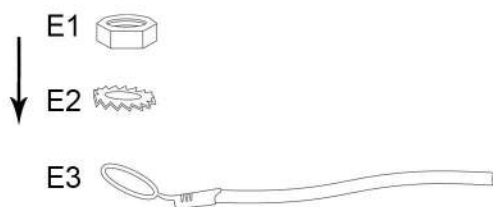
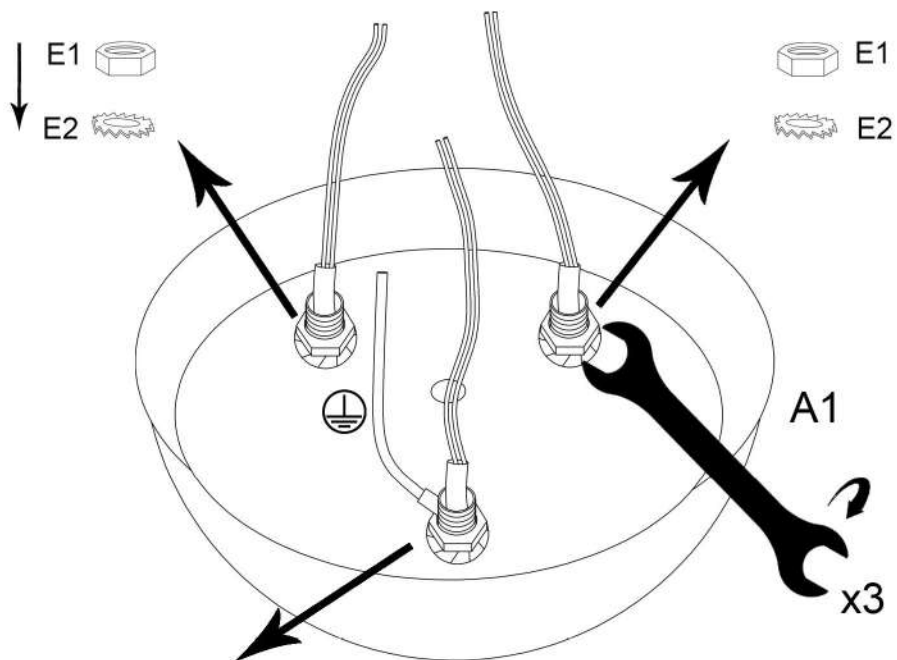
INSTALLATION INSTRUCTIONS

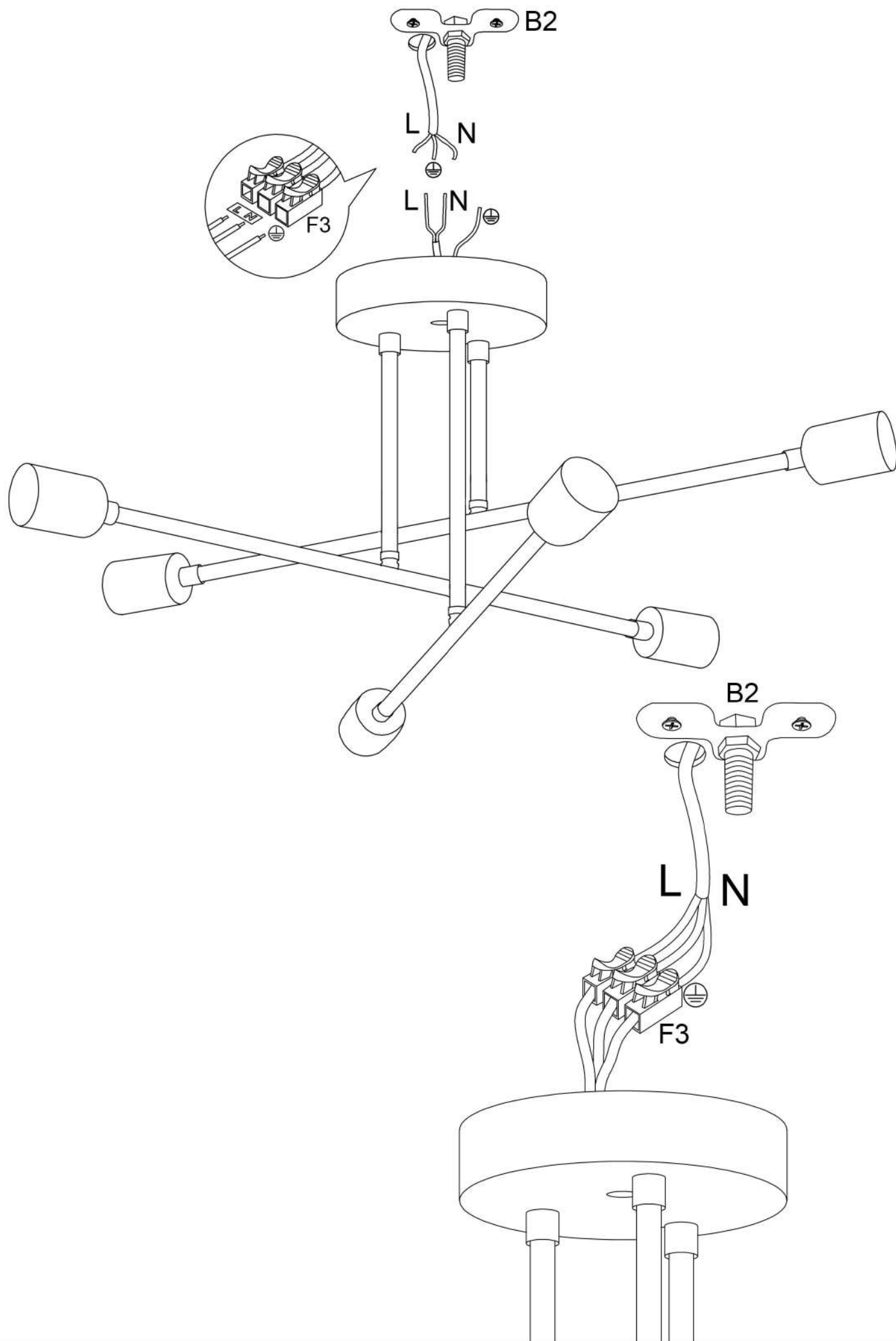
1. The installation of all electrical products should be undertaken with utmost care and a qualified electrician should carry out the work to ensure compliance with any local wiring regulations.

5. Ensure the light source is compatible with local voltage and follow any maximum wattage instructions shown on the product itself.

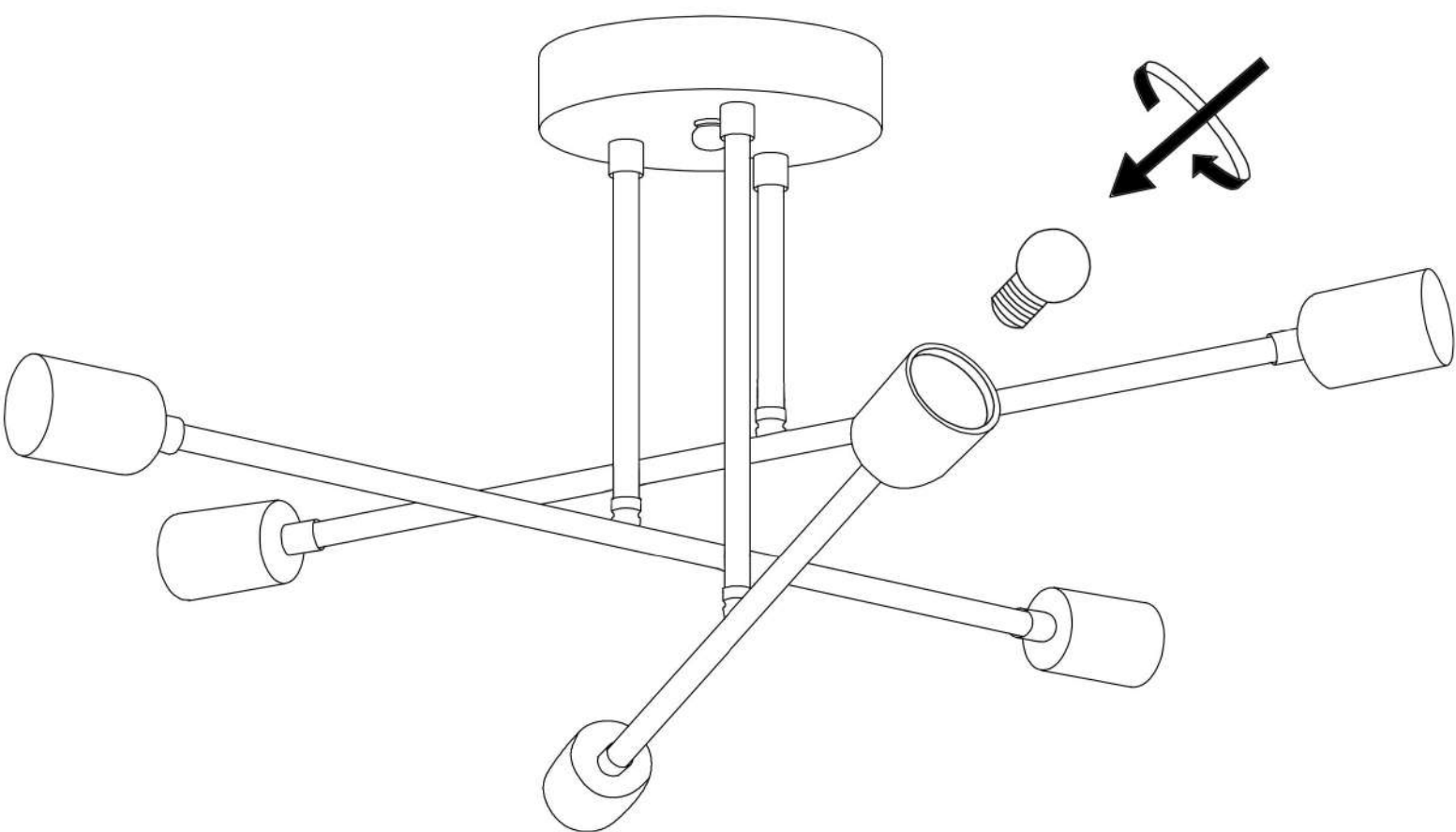
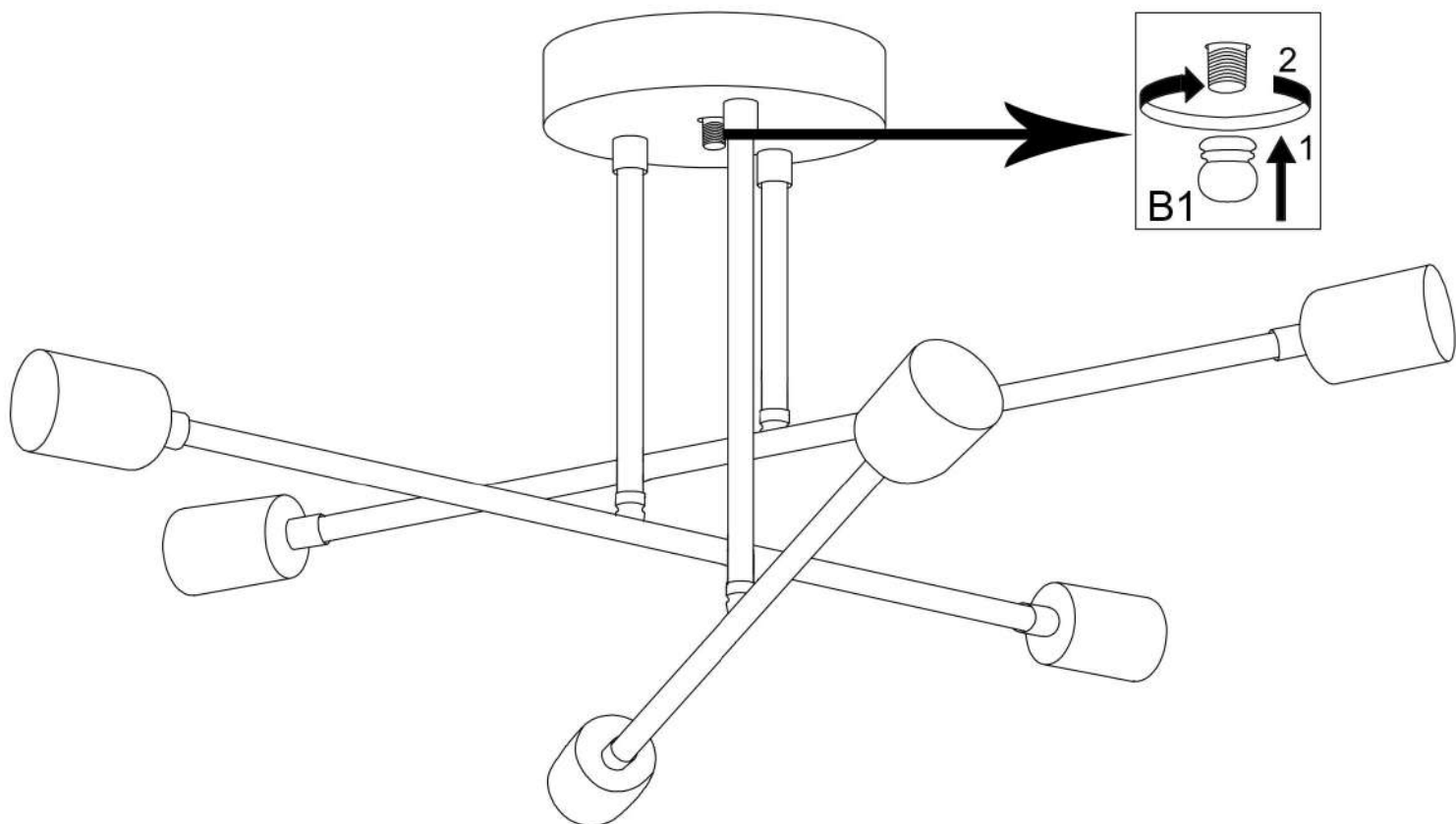
